ADHERENCE AND EFFECTIVENESS TO ANTI-SLAVERY AND HUMAN TRAFFICKING

The Company and its employees maintain a zero tolerance to slavery and human trafficking. We expect all those in our Company, supply chain and contractors to comply with this same value.

- Completion of supplier audits and evaluations, and
- Use of labour monitoring and payroll systems.

For the next financial year 2017/18, our plan is to adopt the same initiatives, ensuring we are not supporting slavery and human trafficking in any way whatsoever.
